

2016 NCMC Award of Special Recognition

The NCMC Awards of Special Recognition honors an individual, group, or business affiliated with a museum in North Carolina who has demonstrated significant interest and support in the programs, goals, and policies or made significant contributions of time, money, or ideas to a museum in the state.

Up to three NCMC Awards of Special Recognition may be awarded each year.

The Awards Committee may choose to make no award or to make multiple awards in one or more categories: Individual or Individuals including museum volunteers; Group or Organization; and Business, Corporation or Foundation.

A complete nomination package, including the nomination form and all requested supporting documents and materials as specified below, is required for review and evaluation. Nominations that are incomplete may be returned, requesting missing information, or may be excluded from consideration, depending on the timeframe and other factors.

This year all completed award nomination forms and required support documentation must be **submitted electronically to awards@ncmuseums.org by February 10, 2017.**

Acceptable formats include .pdf and .jpeg files. Accompanying letters of support, if required, must be sent by the letter-writer directly to awards@ncmuseums.org. Please reference the award in the subject of your email, for example 2016 NCMC Award of Special Recognition
